Sub: Payment of Arrears and Interim Increase in Tuition Fee on account of implementation of 7th Central Pay commission recommendations in Private Unaided recognized schools of Delhi

Dear Parents,

The Directorate of Education vide its Order No. DE.15(318)/PSB/2016/19786 Dated 17.10.2017 implemented the 7th Central Pay Commission recommendations under Central Civil Services (Revised Pay) Rules, 2016 with effect from 01.01.2016 for the employees of Private Unaided Recognised Schools of Delhi.

Accordingly, the Managing committee of the school in its meeting held on 20.11.2017 decided to implement the 7th Central Pay Commission recommendations for the employees of Bal Bharati Public School, Pitampura, Delhi with effect from 01.01.2016. As per the orders issued by the Directorate of Education the staff is to be paid arrears with effect from 01.01.2016 till 30.11.2017 and the increased salary with effect from 01.12.2017.

The Directorate of Education has allowed Interim Fee Hike @ 7.5% with effect from 01.01.2016 and @ 15% with effect from 01.07.2017 to the Private Unaided Schools and has allowed the schools to recover the arrears of Tuition Fees till 30.11.2017 and recovery of increased Tuition Fees with effect from 01.12.2017. We have accordingly calculated the arrears of fees hike till 30.11.2017 which are payable as under:-

For PP-I and PP-II arrears have been calculated for 8 months and 20 months respectively. For other classes, arrears have been calculated for 23 months. For the students who have joined school afterwards the arrears would be proportionately reduced. The students of class-XII are to pay total amount of arrears in one installment.

The Tuition Fees will increase with effect from 01.12.2017 as under:-
