CIRCULAR

Subject: Online entry on the e-district portal of beneficiaries under the Centrally Sponsored Scheme "Pre-matric and Post-Matric Scholarship for SC/ST/OBC students" for the year 2021-22 for Delhi Govt./Govt. Aided/Recognized Unaided Private Schools and online verification of applicant students.

The attention of all Head of Schools (HoSs) is invited to the circular bearing Nos. F.DE.18-3(20)/PLG/2021-22/2494-2498, F.DE.18-3(20)/PLG/2021-22/2499-2503, F.DE.18-3(20)/PLG/2021-22/2504-2508, F.DE.18-3(20)/PLG/2021-22/2509-2513 dated 04.10.2021. In this regard, all of you may be aware that the eligible students of Govt and Govt Aided schools under the scheme of Pre-Matric Scholarship Scheme for SC/OBC students and Post-Matric Scholarship Scheme for SC/OBC students **have to apply on the e-district portal for the current academic session 2021-22**. The last date of submitting online application on e-district by eligible students under the aforesaid scheme is **31st January 2022** as per information provided by the Department for the Welfare of SC/ST/OBC (DSCST), Govt of NCT of Delhi. Through the abovesaid circulars dated 04.10.2021, all HoSs were requested to nominate a Nodal Officer to assist the eligible students to apply online through setting up a Help Desk.

During the intervening period from the launching of the scheme for 2021-22, some schools have raised the query/grievance regarding inactive login credentials for doing the online verification of applications on e-district portal. The issue was referred to DSCST, GNCTD and now they have responded that they have resolved the issue. In this reference, an e-mail along with procedure/steps for updating the login credentials of Institute Nodal Officer (INO) of school on e-district portal, received from DSCST, GNCTD is attached herewith. Accordingly, after updation/creation of login credentials of INO of school duly approved by DDE (Zone) concerned, INOs will be able to verify applications on e-district portal in r/o aforesaid schemes.

At last, all HoSs are requested to kindly ensure timely completion of work of online verification of applications. In case any login issue, HoSs should contact concerned DDE (Zone).


