- 6. That more sport material for out-door games shall be purchased and made available to the students.
- 7. That the school shall strictly abide by the provisions of Section 10(i) of the Delhi School Education Act 1973, and payment shall be made through crossed cheque. Bonus, LTC., medical allowance, gratuity and pension as applicable to Govt. Employees of Delhi Admn. shall be paid to the employees of the school.

That the enrolement of each section shall not exceed the number of students calculated @ 12 sq.ft. per student for the available floor area of the class room and the school shall provide adequate and sufficient recommonation as per the norms of the Directorate of Education in each class.
